2. Standard of Physical Fitness/Medical Examination:

Candidates shall be eligible for the engagement as act apprentice, duly satisfying the minimum standards of physical fitness specified in **Schedule-II of Apprenticeship Rules 1992** (as amended time to time) and Medical certificate in the prescribed format to be produced at the time of document verification.

The Medical certificates should be signed by Government Authorized Doctor (Gaz.) not below the rank of Asst.Surgeon of Central/State Government Hospital in terms Railway Board's letter no E(MPP)/2009/6/14 dated 04.12.2018.

2.1.a: बेंचमार्क दिव्यांग उम्मीदवारों की योग्यता/Eligibility of Person with Benchmark Disability Candidates:

Ministry of Law and Justice (Legal Department), Government of India Vide Gazette Notification No.59 of 28th December 2016, Section 34(1), the reservation of persons with Disability (PWD) is 4% for the five categories of benchmark disability.

The Schedule (Clause ZC of Section (2)) of The Rights of Persons with Disabilities Act 2016 - defines the categories of benchmark disability and specifies the means of disabilities respectively.

Ministry of Skill Development & Entrepreneurship (MSDE)(Apprenticeship Training Division) vide Letter No.MSDE-4/3/2023-AP(PMU) Dated:11-04-2025, has advised the trade eligibility list of 266 designated trades under Apprenticeship Training Scheme as per RPWD Act, 2016. The engagement of apprentices in the designated trades is subject to the permissible standards of medical fitness, as furnished hereunder;

2. 1.b. Disability Certificates:

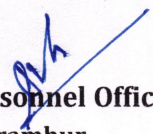
